LESSONS LEARNT AND RECOMMENDATIONS

WHAT WE HAVE LEARNT, OUR PROPOSED SOLUTIONS & RECOMMENDATIONS

LESSON - 1

- **For a successful program the participants selected need to have met certain basic criteria**

DETAIL

- Have a registered IP
- Negotiated with University on ownership of the IP (Implies the University has a startup policy)
- Registered a company to commercialize the innovation

WHAT HAVE WE DONE / PROPOSE TO DO?

- **Done:** We have updated the selection criteria to include these aspects
- **In progress:** We shall also communicate to institutions on why we have not selected participants from their institutions

WHAT WE HAVE LEARNT, OUR PROPOSED SOLUTIONS & RECOMMENDATIONS

LESSON - 2

- **When working with researchers from institutions the institutional preparedness from an R2C perspective is critical**

DETAIL

- Does a commercialization pathway exist (startup policy/TTO)?
- Is there institutional buy in ?
- What additional support is there for the innovator?

WHAT HAVE WE DONE / PROPOSE TO DO?

- **In progress:** Collaborating with KENIA on the institutional strengthening program
- **Proposal:** Capacity building for institutional leaders
- **Proposal:** Development of tools to support / help the institutional to accelerate their R2C journeys

WHAT WE HAVE LEARNT, OUR PROPOSED SOLUTIONS & RECOMMENDATIONS

LESSON - 3

- **Raising funding for the innovators is not as straight forward**

DETAIL

- With some of the challenges identified the funding discussions are not moving as fast.
- The most ideal funding for most of the innovators is grant funding

WHAT HAVE WE DONE / PROPOSE TO DO?

- **In progress:** We are reaching out to various partners to see if they can finance the cohort as a whole
- **Proposal:** RISA creates an allocation to provide seed capital to the current and the second cohort of R2C

WHAT WE HAVE LEARNT, OUR PROPOSED SOLUTIONS & RECOMMENDATIONS

LESSON - 4

- **It will take an innovator longer than six months to achieve the desired commercialization / funding success.**

DETAIL

- With the current cohort we are having to start from discussions from the IP status, whether a licensing agreement has been discussed with the institution etc
- For those ready some discussions are underway but moving slowly
- Some of the innovation need more work to get to MVP status

WHAT HAVE WE DONE / PROPOSE TO DO?

- **In progress:** Ramped up market outreach and investor discussions
- **Proposal:** We propose that R2C is run as a multi year program

WHAT WE HAVE LEARNT, OUR PROPOSED SOLUTIONS & RECOMMENDATIONS

LESSON - 5

- **The innovators need more technical support to get them ready to meet investors**

DETAIL

- While coaching has added a lot of value the innovators require more support to go to market this includes
 - IP registration for those who have not
 - Financial model build to support their funding needs
 - Pitch development to ensure their decks match up to investor expectations
 - Additional coaching hours in certain areas eg design thinking

WHAT HAVE WE DONE / PROPOSE?

- **Proposal:** We are requesting for an extension budget to support these initiatives

WHAT WE HAVE LEARNT, OUR PROPOSED SOLUTIONS & RECOMMENDATIONS

LESSON - 6

- **TOT participants need more help to roll out R2C programs in their institutions**

DETAIL

- We have received several request to be part of the R2C interventions the ToTs are planning in their institutions
- Some of the ToTs need more help with content delivery for R2C

- **Proposal:** Budget allocation to be able to attend some of the events
- **Proposal:** Create an eLearning platform to support ToTs

LESSON - 7

- **To ensure success of the ToTs institutional strengthening is critical**

DETAIL

- Does a commercialization pathway exist (startup policy)?
- Is there institutional buy in

LESSON - 8

- **R2C curriculum had some gaps**

DETAIL

- We had to do a lot of customization to ensure that the developed curriculum in phase 1 was fit for purpose
- Made edits and even developed additional content

WHAT HAVE WE DONE / PROPOSE TO DO?

- **In progress:** Additional content development and customization

WHAT WE HAVE LEARNT, OUR PROPOSED SOLUTIONS & RECOMMENDATIONS

LESSON - 9

- **Program success cannot be evaluated in 6 – 12 months**

DETAIL

- With the exiting R2C ecosystem state, level of institution preparedness for R2C, innovator starting points the program success will be seen in the medium to long term but not in the short term

WHAT HAVE WE DONE / PROPOSE TO DO?

- **Proposal:** Make program multi year intervention
- **Proposal:** Create additional budget for MEAL

WHAT WE HAVE LEARNT, OUR PROPOSED SOLUTIONS & RECOMMENDATIONS

LESSON - 10

- **There is a lot of demand for R2C programs**

DETAIL

- Webinars have consistently registered an average of 50 participants
- Requests from additional institutions for R2C support – NRF, Universities
- Requests to expand to Ethiopia, Ghana etc

WHAT HAVE WE DONE / PROPOSE TO DO?

- **Proposal:** Create an eLearning platform to support in scaling of R2C program
